Historically Speaking...

You do not need to be a Legacy or relative of a Junior Service League member to join Junior Service League! No, I am not a Junior Service League of Independence Legacy. In fact, I was born in the bootheel of Missouri and did a brief stint in the Raytown School District, before moving to St. Joseph where I graduated from high school. My early ties to the Independence area include my mom teaching at Truman High School, my third-grade presidential report on Harry S Truman, and then an unexpected opportunity to work as a key grip for a documentary about Harry S Truman which lead me "behind the scenes" of the Truman Library during my high school years.

I moved to Independence after graduating from Southwest Missouri State (now Missouri State) in Springfield. My impression of Junior League or in our case Junior Service League was that it was strictly for high society ladies with money and connections. I only wore white gloves for marching band and pearls were only worn for the sorority composite photo, this was going to be interesting.

After living in Independence for a while I wanted to become more involved in the community and start connecting with like-minded women. I started to hear about an organization called Junior Service League however you had to have a connection for an invitation to join. I didn't know a soul in Junior Service League and since Google wasn't a thing yet... I had no idea how to go about finding my connection. But finally, it happened!!

I am in another organization with Helen Hatridge and through conversation the planets aligned, I held my mouth just right and I received an invitation to join League! Words cannot express how humbled and honored I was that Helen felt I would be a strong member. I guess in a way I am kind of a legacy. Helen and I are P.E.O Sisters!

In 2006 our Provisional Class, a strong but mighty group of 8, started out wide eyed and little bit clueless into the world of Junior Service League. A core group were already friends and legacies leaving the rest of us to get up to speed. We bonded quickly and after the historical tour, the Provisional Reception, our interpersonal meeting and retreat we started working on our "project". We were a bit torn on what to do. We received feedback from membership that we should put on a social event, but in our hearts, we wanted to do some type of service project. After brainstorming we put together a Trivia Night at the Clubhouse to socialize and raise money! Trivia Night was the last event in the Clubhouse before the big renovations and the evening was capped off with our members leaving messages and signing the walls! (how fun not to get yelled at for writing on the walls!!)

So here I am almost 13 years later, still an Active member of Junior Service League. I will never be a Legacy, but I hope to leave a little piece of my legacy as a member of Junior Service League.

NOMINATING - Stephanie Hall

The Nominating Committee is already planning for the election of the 2020-2021 Officers. Our committee nominates a single slate of candidates for the following elective Offices: President, Vice President, Secretary and Treasurer. The Nominating Committee is comprised of members that were voted on by JSL membership and the Board. The committee discussions are completely confidential. Our desire is to select the best team that will help JSL create an impact on our community and fulfill our mission.

To be eligible to serve as an elected Officer you must meet the following criteria:

- □ Active member
- ☐ Member in good standing
- ☐ Served at least one term on the Board

As JSL's Nominating Committee, we want to ensure that the best leader is placed in the best possible position. Please use the descriptions below as a guide to learn more about the elected Offices. The current and past Officers are happy to answer any questions you may have about each Office!

President: The President shall preside at all meetings of the League, and shall have the power to transact all of the usual, necessary and regular business of the League as may be required

and, with the prior authorization of the Board of Directors, to execute, with the joinder of the Treasurer, all contracts and other documents as shall be required by the League, appoint the Advisor from the sustaining membership, and in general, perform all other duties incident to the office of president. The President shall be an ex-officio member of all League committees, except the Nominating Committee.

<u>Vice President</u>: The Vice President shall assist the President and shall act in the absence of the President and when so acting, shall have all the power and authority of the President. The Vice President shall serve as the chairperson of the Bylaws and Long Range Planning Committee and perform all other duties incident to the office of the Vice President.

<u>Secretary</u>: The Secretary shall record and preserve the minutes of all Executive Committee, Board of Directors and General Membership meetings. She shall submit an annual report of the League records in accordance with applicable federal and state laws and shall perform all other duties incident to the office of secretary. The secretary shall record the attendance of members, keep membership records including placement and service information.

Treasurer: The Treasurer shall be responsible for all League funds, shall direct that such funds be deposited in such financial institutions as the Board of Directors determines, keep accurate accounts, and present a monthly financial statement to the League. The Treasurer shall collect all dues and fines, receive donations to the League, notify all members of dues obligations and penalties, and provide receipt of contributions. The Treasurer shall present a proposed budget to the members for approval at the first business meeting of the fiscal year, shall be the chairperson of the Finance Committee, an ex-officio member of the Resource Development Committee, an ex-officio member of the Property Committee and shall perform all other duties incident to the office of Treasurer.

This year we are asking members to complete a Willingness to Serve Form as a communication tool between members and the Nominating Committee. If you are interested in serving in a leadership role, we want to know! Please begin thinking about how you want to serve as a member of JSL next year. The Willingness to Serve Forms are available now. The Nominating Committee will accept completed forms by email, mail or in person through December 8th. The form has been included in the Sentinel and will be available at Business Meetings. Our Committee encourages all active members to complete this form. The Nominating Committee will review the completed Willingness to Serve Forms in December 2019.

The Nomination Form will be available in January 2020. The Nominating Committee depends on input from membership in order to present a slate of officers. If an active member or committee chair has impressed you with their abilities, be sure to let the Nominating Committee know.

The input from members will be given careful consideration when the Nominating Committee meets in February 2020. The Slate of Officers will be proposed to membership in March 2020.
